It is quite heartening to know that this State has been declared as Corona free State of our country. It is the result of combined efforts of your Department and all the concerned authorities of this State.

The hospital of Gomantak Ayurveda Mahavidyalaya & Research Centre "Kamakshi Arogya Dham" at Shiroda was taken over by the Govt. on 27th March 2020 in order to utilize the same as a place of quarantine for the suspects of COVID -19 in case of the need. We had requested some IPD patients who were in the hospital to go to their homes and follow the treatment so that the Govt. may be able to utilize the premises for the said purpose. Since then this hospital is kept vacant for the use of Govt.
